
INTRODUCING ZOT - THE ENERGYBOT! Spreading the safety message to Auckland school kids.

IF YOU DON'T USE MUCH ELECTRICITY, YOU MIGHT BE ABLE TO SAVE EVEN MORE ON YOUR POWER BILL!

Alongside electricity retailers, Vector helps low-use residential consumers by offering low fixed-charge price plans. These include fixed charges of no more than 30c a day. These are generally the best option if you use less than 8,000 kWh per year on the Vector network.

They do have higher variable charges, but will still be cheaper for you if you use less than 8,000 kWh.

If you want to know how much electricity you use, which price plan you are on or whether you are eligible for a low fixed-charge plan, call your retailer - it could save you money!

ABOUT OUR KINGFISHER.

On the front of our brochure you may recognise our little friend, Kenny the kingfisher. Also known as the kōtare, he keeps a vigilant eye over Auckland and knows the region's power lines like the back of his claw. In these respects, he's much like us at the Auckland Energy Consumer Trust.

Not only do we look after Auckland's power network, but we also oversee the whole area, making sure that households get the most from their power dollar. Arguably, Kenny has nicer feathers though.

If you're an AECT beneficiary, a little birdy will drop a dividend in your mailbox in September. It's usually a few hundred dollars, so it's well worth spending just a couple of minutes filling out the enclosed form so we can credit the money directly to your bank account. If this is the first time you're receiving a dividend from us or you're in the dark about what we at the AECT do for you, you'll find more information in the rest of this pamphlet.

WHAT DOES THE AECT DO?

AECT is the majority shareholder in Vector. Our main role is to protect and manage the investment we have in Vector on your behalf.

Vector provides electricity, gas and fibre optic networks across the country used by over a million Kiwis. The Trust provides governance to ensure Vector is a stable, profitable, well-run organisation.

Our success as a trust ensures that nearly 315,000 people within the AECT district receive a dividend each year.

HOW DO I BECOME A BENEFICIARY?

Simply by living in the AECT district and being a Vector electricity customer when the dividend roll is struck. This means most people in the zone highlighted on the map overleaf will be receiving a dividend in September.

WHO IS THE AECT?

That's us. Auckland Energy Consumer Trust is an elected trust consisting of five trustees.

ABOUT WITHHOLDING TAX.

We are required by Inland Revenue to withhold tax at 33% on distributions made to our beneficiaries. However, over 75% of our beneficiaries will be on an income tax rate of 17.5% or lower, so could well be paying too much tax on their distribution.

We're actively working with the Inland Revenue, Ministers and MPs to rectify this. But until Wellington changes its tune, if you believe you're among the 75%, you could potentially receive a tax refund by filing a tax return. COMMON QUESTIONS.

WHO IS ELIGIBLE FOR THE AECT DIVIDEND?

Everyone who is an AECT income beneficiary when the dividend roll is struck. You are an AECT income beneficiary if you are a Vector electricity customer in the Trust District. This includes Auckland, Manukau and northern Papakura.

The dividend is paid regardless of who your electricity retailer is, as long as your name is on the power bill. In the case of rental properties, this is usually the tenant rather than the owner of the building.

WHEN WILL THE NEXT DIVIDEND BE PAID AND HOW MUCH WILL IT BE?

The dividend is usually paid in September/October. The amount depends on the number of beneficiaries to be paid and financial results from Vector, which won't be known until later in the year. Last year it was \$330.

WHAT HAPPENS IF I MOVE BEFORE THE DIVIDEND IS PAID?

As long as you're a Vector electricity customer and live within the Trust District when the dividend roll is struck, you will still receive the dividend. Your details will be included in the roll we receive from your electricity retailer later in the year. But if you move out of the Trust District before the roll is struck, you won't be eligible for the dividend. Please note, some apartment buildings and residential developments inside the Trust District do not qualify for the dividend because they do not use the Vector electricity network.

IMPORTANT INFORMATION: YOU NEED TO READ THIS!

- The AECT will be paying a dividend later this year.
- The money will be paid to people who are customers of Vector electricity in the Trust District of Auckland, Manukau or northern Papakura when we finalise the dividend list.
- The money will be paid to the person or organisation whose name is on the power bill.
- If the name on your power bill is not the same as your bank account and you want to get your dividend as a cheque or direct credit, please update your details with your electricity retailer – the AECT can't do this for you.
- If you want to get your money faster, please fill out and return the direct credit form from this pack.
