


FREQUENTLY ASKED QUESTIONS

Can I change the name on the cheque?

No. For your security, the cheque needs to go into a bank account in the same name. We get customer names from your electricity retailer; so if it's wrong, please contact them to get it updated for next time. If you can't bank the cheque, the form it came with explains how to return it and have your dividend credited to your power bill instead.

Why haven't I got my direct credit or power account credit yet?

Payments were made on 19 September. If you were expecting a direct credit, check that the bank account shown on the letter is right – call us ASAP if it isn't. If your account number is right but you haven't received a dividend, please contact your bank to see what's happened. Credit to power accounts will show up on your power bill, but how long this takes depends on when your electricity retailer puts it on your power bill.

Who gets a dividend?

If you're in the Entrust District, the dividend is paid to the person named on the power bill as at midnight Wednesday 1 August 2018.

Why is Vector giving me an extra \$30?

The \$30 from Vector comes from a refund to customers on power costs and has been added to this year's Entrust Dividend. See the separate leaflet from Vector for more information.
