We've been paying dividends since 1994. The amount may change, depending on Vector's profit, but every dividend is money in the hand for our power account holders. We are proud to have paid out more than \$2 billion over 28 years.

Provide us with payment details

Your dividend is paid into your bank account or as a credit on your power bill. If we did not have all the details to process your payment, we will have sent you a dividend notification form.

You need to take action to ensure you get paid as quickly as possible – fill in your details on the enclosed form and send it back to us either by using the reply-paid envelope supplied or by email at dividend@entrustnz.co.nz.

You can make it easier next year by providing your power company with your email address. This will enable us to email all correspondence to you and you'll be able to use our secure web page to update your payment details.
